I. ORGANIZATION

- A. United Methodist Women is a lay women's organization, rooted in mission. Membership is open to any woman who shares its purpose.
- B. Officers and members are governed by the Constitution and By-laws for the local, district, and the Conference organization of the United Methodist Women.

II. ANNUAL MEETING

- A. The date and place of the District Annual Meeting will be set by the District Executive Committee.
- B. The voting body of the Annual Meeting shall be composed of those present from each local unit, including representatives from each church in a charge unit, all elected district officers and District committee chairpersons, all elected Conference officers, the District Superintendent, and any member of the Women's Division of the General Board of Global Ministries and Jurisdiction officers residing within the bounds of the District.
- C. Official notice of the Annual Meeting shall be in the hands of the local Presidents and District members no later than six weeks prior to the date of the meeting.
- D. All District business shall be transacted through the proper committees and approved by the Executive Committee before being presented on the District floor.
- E. Expenses of the Annual Meeting shall come from the District Administration and membership Development Fund. The offering taken at the Annual Meeting shall go to a project recommended by the District Executive Committee and voted on by the body.

III. ELECTION OF OFFICERS (following the pattern established in 1993)

- A. At the District Annual Meeting in odd numbered years, officers elected for a two (2) year term shall be:
 - 1. President
 - 2. Secretary
 - 3. Mission Coordinator for Spiritual Growth
 - 4. Mission Coordinator for Social Action
 - 5. Secretary for Program Resources
 - 6. Coordinators #3 and #4 may be combined as necessary.
- B. Officers elected for a two (2) year term in even numbered years shall be:
 - 1. Vice President
 - 2. Treasurer
 - 3. Mission Coordinator for Education and Interpretation
 - 4. Mission Coordinator for Membership/ Nurture/ Outreach
 - 5. Communications Coordinator
 - 6. Chairperson, Committee on Nominations
 - 7. Coordinators #3, #4, and #5 may be combined in a way as deemed necessary.

C. Appointive Officers.

The offices of Historian, Chairperson on Standing Rules and Parliamentarian shall be appointed by the President in consultation with the Executive Committee and shall serve on the Executive Committee. Tenure shall be the same as elected officers.

D. Tenure.

No elected leader shall hold the same office for more than four-year tenure. The elected leadership of the District Organization shall be limited to a total of eight (8) year, the exception being a woman who has completed her eight-year tenure, (serving in elected leadership other than President) is elected President.

E. Service of six months to a year as an officer or coordinator may not be counted as tenure in that position. Tenure may be continued or may begin as deemed necessary and as directed by the Lubbock District President.

F. Newly elected officers take office upon installation, except Treasurer, who takes office January 1.

IV. GUIDELINES FOR DISTRICT COMMITTEE ON NOMINATIONS

A. The Nominating committee shall consist of five (5) members who shall be nominated and elected by the District at the time officers are elected. Terms are four (4) years, except when classes are established for the first time.

1. One member to be elected in odd number years.
2. Two members to be elected in even numbered years.

B. The Chairperson of the Nominating Committee shall be elected two years during her four-year term. While serving as Chairperson, she shall be a member of the Executive Committee.

C. Vacancies that occur on the Nominating Committee shall be filled by the Committee with concurrence of the Executive Committee.

D. No one may serve more than four (4) years on the Committee on Nominations.

E. A two (2) year term as Chairperson on the Nominating Committee may be in addition to tenure limitations on the District Executive Committee.

F. The Committee shall meet at least twice a year, as well as on call of the Chairperson.

G. Slate of officers shall be in the hands of the President six weeks prior to the Annual Meeting for approval of the Executive Committee, to be sent on to local presidents four weeks before the meeting.

V. BUDGET AND FINANCE

- A. The District Treasurer shall be a member of the Conference Finance Committee. If she cannot attend a meeting, the President shall attend.
- B. The District shall present a budget for the ensuing year by September 1 in order to receive Conference A&MD funds.
- C. At the closing of the calendar year, after all bills have been paid, district Treasurers shall send surplus funds exceeding the amount of \$1500.00, marked clearly as A&MD to the Conference Treasurer as an Undesignated Pledge.

VI. EXPENDITURES

- A. Expenses for the District Annual Meeting shall come from the District A&MD Fund.
- B. President Expenses
 1. Total expenses for the School of Christian Missions.
 2. Total expenses for United Methodist Women's Conference Annual Meeting.
 3. Expenses for Northwest Texas Annual Conference, as the budget allows.
 4. Expenses for Assembly and Jurisdiction from Conference Accrual
- C. Mileage
 1. Seventeen cents (\$.17) per mile is allowed for cars.
 2. Members shall be expected to travel in carpools whenever possible.
 3. Guest speakers shall be paid seventeen cents (\$.17) per mile. They may be paid an honorarium not to exceed \$50.00.
- D. District Officer Expenses, As Budget Allows
 1. For School of Christian Missions
 2. For UMW Conference Annual Meeting
 3. For visits to local units (one per year, unless the unit is just being organized)
 4. Each officer, who attends a meeting at District expense, is expected to channel learned information to the Executive committee and local counterparts.
 5. For Legislative Event
- E. Other Expenses and Policies
 1. Gifts of special recognition and/or gifts to mission shall be given by the District to honor District workers who have served terms of four or more years on the Executive Committee. Only gifts representing the District may be presented on the floor or in a District meeting.
 2. A minimum gift of five dollars (\$5.00) will be sent from the District as a memorial, should a death occur among members of the Executive Committee (a parent, husband, or child).
 3. Nursery care and expenses incurred for District Meetings shall be paid by the District.
